



ASSUMPTION AND ACKNOWLEDGEMENT OF RISKS, DANGERS AND HAZARDS AND RELEASE OF LIABILITY

In consideration of receiving permission from the 1Voice Foundation, Inc., a Florida corporation (the "Foundation") to enter upon, access and participate in the Foundation's events, free of charge either as a volunteer, guest or in such other, similar capacity, I hereby understand and agree upon the following for myself and any minor children for whom I am parent, legal guardian, or otherwise responsible, and for my/our heirs, personal representatives or assigns:

1. ACKNOWLEDGEMENT OF RISKS.

Freely and voluntarily assume and acknowledge the risks, dangers and hazards inherent in all of the events or activities of the Foundation, including but not limited to risks involving vehicles, real property, moving machinery, equipment, equipment failure, operator failure, uneven or slippery surfaces, loud noises, inclement weather, lighting, variances, and extremes of wind, weather and temperature, the presence of insects and wildlife forms including dangerous reptiles, snakes, and biting or stinging insects, heat or sun related injuries or illnesses, including sunburn, sunstroke, or dehydration, fatigue, chill and/or dizziness, which may diminish my/our reaction time and increase the risk of an accident and other hazardous condition. Nonetheless, I elect to voluntarily participate in the events or activities of the Foundation and waive notice of any and all risks and hazardous conditions that may exist, and voluntarily assume all risks of loss, damage, or injury, including death, that may be sustained by me, or any property of mine, while participating in the event or activity for or on behalf of the Foundation either as volunteer, assistant, guest or otherwise.

2. EXPRESS ASSUMPTIONS OF RISK AND RESPONSIBILITY.

I further agree to assume responsibility for all the risks in participating, attending the event or activity, whether identified above or not. My/our desire to volunteer and otherwise participate in any event or any activity is purely voluntary. I assume full responsibility for myself and my minor children for whom I am responsible, for any bodily injury, accident, illness, paralysis, death, loss of personal property and expenses thereof as a result of any accident that may occur while I/we have participate in the events and activities of the Foundation.

3. RELEASE.

I further release the Foundation, its principals, directors, officers, managers, members, agents, employees, volunteers, and their families, and their insurers, from any and all liability, claims, demands, actions, and causes of action of any nature whatsoever, whether legal or equitable, arising out of or related to and loss, damage, of injury, including death, that may be sustained by me, or my minor children or any of my/our property, while participating in the event or activity regardless of the cause.
